#### Aim

"All children & young people should enjoy Lisburn YMCA facilities & activities without fear of physical, sexual or emotional abuse."

# **Policy Statement**

Lisburn YMCA is committed to taking every appropriate step to ensure the safety and well-being of the young people with whom it works, regardless of class, gender, race or creed. This policy applies to all children and young people with whom Lisburn YMCA is involved with regardless of age.

Lisburn YMCA is truly committed to safeguarding the well-being of its members, staff and volunteers, who should at all times show, and be shown, respect and understanding regarding their rights, safety and welfare.

#### **Practice**

When working with children and young people, Lisburn YMCA will:

- Promote the general welfare, health and personal development of children and protect them from harm.
- Recognise that children have rights as individuals and treat them with dignity and respect.
- Raise awareness about what children are entitled to be protected from.
- Adopt and apply a thorough and clearly defined method of recruiting and selecting staff and volunteers.
- Plan an appropriate response to accidents and complaints and to alleged or suspected incidents of abuse.
- Establish links with parents and other relevant organisations.

#### **Designated Child Protection Officers**


Our Designated Officers are responsible for ensuring our staff & volunteers follow our child protection policy & procedures. They are also responsible keeping in touch with other agencies, such as Social Services, and dealing with all concerns of a child protection nature.
